### I. Rental Period

The rental period begins upon delivery and setup by Baby Got Bounce, LLC and ends at the agreed-upon pickup time. Customer agrees not to use the equipment after the scheduled pickup time without prior approval.

### II. Payment

A deposit will be required to reserve equipment. Full payment is due before setup unless otherwise agreed upon in writing. Deposits are non-refundable except as outlined in the cancellation policy.

### III. Cancellation Policy

Cancellations made at least 48 hours before the rental date may receive a refund of any deposit paid.

Cancellations within 48 hours of the event may result in forfeiture of the deposit.

Weather-related cancellations may be rescheduled based on availability.

### IV. Safety Rules

Customer agrees to ensure that:

- Adult supervision is present at all times while the inflatable is in use.
- No persons are on the equipment during inflation or deflation of the inflatable.
- No persons under the influence of alcohol or any illicit drugs shall be permitted on the inflatable.
- No shoes, sharp objects, food, drinks, gum, silly string, face paint, glitter, or pets are allowed on the inflatable.
- Use of soaps, oily or suds-producing liquids or any other unauthorized chemicals is strictly prohibited.
- Participants remove eyeglasses, jewelry and any other loose items before entering.
- No roughhousing, flips, wrestling, climbing on walls, or horseplay is permitted.
- Occupancy and weight limits provided by Baby Got Bounce, LLC are strictly followed.
- The inflatable is not used during high winds (20+ MPH), lightning, heavy rain, or other unsafe weather conditions.

### V. Equipment Responsibility

Customer accepts full responsibility for the rented equipment from the time of delivery until

pickup.

Customer agrees to:

- a. Keep equipment in a clean and safe condition.
- b. Prevent damage, theft, vandalism, or misuse.
- c. No bar-b-queing, open flames or heaters of any kind near the equipment.
- d. No smoking on or around the equipment.
- e. Notify Baby Got Bounce, LLC immediately of any damage or issues.

**VI. Damage and Cleaning Fees**

Customer agrees to pay for any damage beyond normal wear and tear, including but not limited to:

- a. Tears, cuts, burns, or punctures.
- b. Damage caused by unauthorized relocation of equipment.
- c. Excessive cleaning required due to mud, food, soap, gum, confetti, silly string or other debris.

**VII. Site Requirements**

Customer is responsible for ensuring:

- a. Adequate space for setup.
- b. Clear access to the setup location.
- c. Access to one or more working electrical outlet(s) within 100 feet of the setup area.
- d. A safe and level setup surface.

**VIII. Liability Waiver**

Customer understands that inflatable equipment involves inherent risks of injury. Customer voluntarily assumes all risks associated with the use of the rented equipment and agrees to release, indemnify, and hold harmless Baby Got Bounce, LLC, its owners, employees, and agents from any and all claims, injuries, damages, losses, or expenses arising from the use of the equipment.

**IX. Weather Policy**

Baby Got Bounce, LLC reserves the right to cancel rentals if weather conditions are deemed unsafe. Safety decisions made by Baby Got Bounce, LLC are final.
